In order to know if there are **violations** which remain unabated or fees that may be outstanding for the property of sale; a certificate of fire code status shall need to be obtained by this office.

Please complete the attached "Certificate of Fire Code Status" form and return to the above address with a check in the amount of \$50.00, payable to the Englewood Cliffs Fire Prevention Office.

**Purchaser must provide** a copy of supporting documentation - e.g., contract of sale, affidavit, etc., before the certificate of fire code status is issued.

N.J.A.C. 5:70-2.2(e). Subsequent owners or those succeeding to control over the premises shall be responsible for correcting unabated violations and for the payment of outstanding fees and/or penalties whether or not they have requested a certificate of fire code status.
