WHEREAS, it is necessary to appoint a member of the Borough of Englewood Cliffs Police Department as the Officer in Charge (Acting Chief of Police) in response the continued absence and retirement of the Chief of Police and shall oversee all matters of the Police Department; and

WHEREAS, in accordance with the Borough Code, Chapter 2, Section 2-13 (Police Department), Subsection 2-13.3 (Designation of Appropriate Authority), the Mayor and Borough Council is designated the appropriate authority and responsible for the overall performance of the Police Department; and

NOW, THEREFORE BE IT RESOLVED, the Mayor and Council of Englewood Cliffs hereby designate Lieutenant James Tracy as the Officer in Charge (Acting Chief of Police) of the Department effective May 23, 2026.

BE IF FURTHER RESOLVED, the designation of the Officer in Charge (Acting Chief of Police) shall be subject to modification as determined by the Appropriate Authority.

Here is a copy of the new e bike law that takes effect on July 1.

I believe there was an indication that the council wanted to share this with the Board of Ed to help educate students

In short, the law changes how certain e-bikes are classified and regulated. A low-speed electric bike is generally a two-wheeled bike with pedals where the motor assists only while the rider is pedaling and stops assisting once the bike reaches 20mph. A motorized bike is broader and includes certain throttle-capable or higher-speed pedal-assist bikes, generally up to 28mph. An electric motorized bike means any two-wheeled bike with pedals and an electric motor capable of greater than 750 watts that can reach speeds greater than 28mph.

E-bikes will now generally be subject to age, licensing, registration, insurance, and helmet requirements. Riders must be at least 15, and must also possess either a valid driver's license, motorized bicycle/e-bike license, or permit. The e-bike must also be registered and insured. Helmets are also mandatory for all ages.

E-bike Definitions

A low-speed electric bicycle (e-bike) is a two-wheeled bicycle with pedals where the motor assists only while pedaling and ceases to provide assistance when the bicycle reaches the speed of 20 miles per hour.

A motorized bicycle (moped) is a pedal bicycle that is throttle-capable of assisted speeds up to 28 miles per hour.

E-bike Requirements

- Minimum age - 15 years old.
- Possess a valid driver license or e-bike license or e-bike permit.
- e-bikes must be registered and insured.
- A helmet is mandatory for all e-bike riders, regardless of age.

E-bike License

- You must be at least 15 years old.
- Schedule an appointment for an e-bike permit.
- Pass the Knowledge and Vision Tests to validate your permit.
- Schedule a Road Test.
- Practice operating the e-bike, unsupervised and during daylight hours, for 45 days.
- Upon passing your Road Test, obtain your e-bike license at an NJMVC Licensing Center.

E-bike Registration

- Obtain e-bike insurance.
- Schedule a registration appointment.
- Provide ID and show valid proof of ownership or affidavit of ownership.
- Provide a Manufacturer's Certificate of Origin (MCO)
- If an MCO, bill of sale or formal proof of ownership is **not** available, the Motor Vehicle Commission may accept an affidavit from the current owner. The affidavit sets forth with reasonable specificity the acquisition of ownership of the e-bike, together with any supporting documents, as proof of ownership of the e-bike.
- Obtain registration.

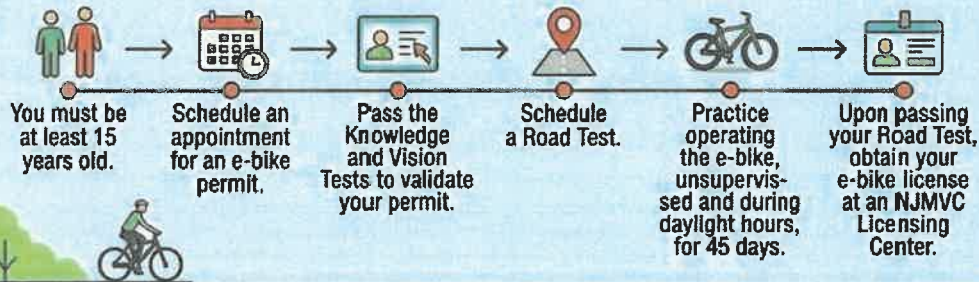

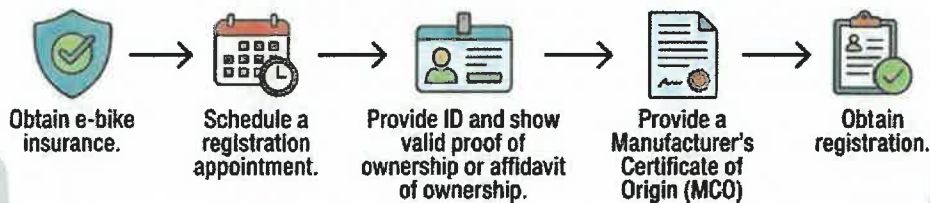

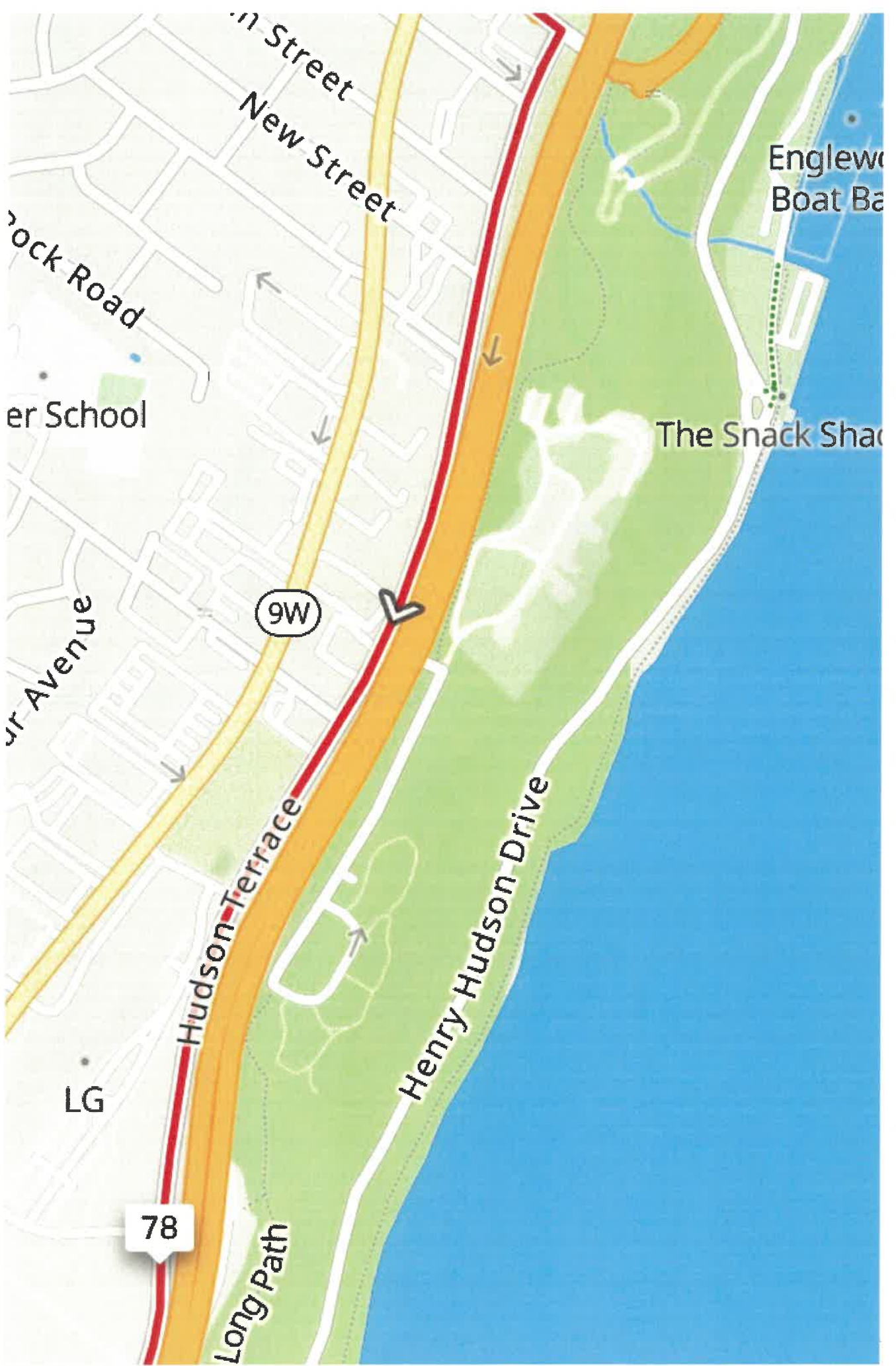

(Monarch Butterfly Conservation Awareness)

Whereas, the Monarch butterfly is an iconic and ecologically significant species known for its extraordinary annual migration across North America; and

Whereas, monarch populations have experienced significant declines in recent decades due to habitat loss, climate change, pesticide use, and reduction in milkweed, the sole host plant for monarch caterpillars; and

Whereas, the Borough of Englewood Cliffs recognizes the importance of pollinators, including monarch butterflies, to maintaining biodiversity, supporting ecosystems, and contributing to agricultural productivity; and

Whereas, local governments play a vital role in protecting and restoring pollinator habitats through community engagement, education, and environmentally responsible practices; and

Whereas, Englewood Cliffs is committed to environmental stewardship and sustainable practices that enhance quality of life for residents while preserving natural resources for future generations; and

Whereas, through participation in the 2026 Monarch Pledge, the Borough seeks to advance conservation efforts by promoting the planting of native species, including milkweed and nectar plants, and encouraging pollinator-friendly landscaping practices; and

Whereas, increasing public awareness and fostering community involvement are essential to reversing the decline of monarch populations and ensuring the long-term viability of this species;

NOW, THEREFORE, BE IT PROCLAIMED, that the Mayor and Council of the Borough of Englewood Cliffs hereby recognize and support Monarch Butterfly Conservation Awareness and reaffirm the Borough's commitment to protecting and restoring monarch habitats; and

BE IT FURTHER PROCLAIMED, that residents, businesses, and community organizations are encouraged to participate in conservation efforts by planting native pollinator gardens, reducing pesticide use, and supporting initiatives that promote ecological sustainability; and

BE IT FURTHER PROCLAIMED that Englewood Cliffs will continue to explore and implement policies and practices that contribute to the preservation of monarch butterflies and pollinator species as part of its broader environmental and sustainability goals.

**TITLE: ORDINANCE TO AMEND CHAPTER 17 OF THE BOROUGH CODE
ENTITLED “FIRE PREVENTION”**

WHEREAS, the Governing Body of the Borough of Englewood Cliffs believes it is in the best interest of the Borough to amend Chapter 17 of the Borough Code entitled “FIRE PREVENTION” as set forth herein.

BE IT ORDAINED by the Mayor and Council of Englewood Cliffs, County of Bergen, State of New Jersey, as follows:

Section 1. Chapter 17 of the Borough Code is hereby amended as follows:

§ 17-9.7 Appointment of Fire Official.

The local enforcing agency shall be under the direct supervision of a fire official who shall be appointed by the mayor and council of the borough, upon recommendation of the ~~line-officers~~ **Chief** of the fire department. The fire official shall serve for a term of one year. Any vacancy shall be filled for the unexpired term. The fire official need not be a member of the fire department nor a resident of the borough. The mayor and council shall specify the salary to be paid to the fire official.

§ 17-9.8 Inspectors — Employees.

Such inspectors and other employees as may be necessary for the local enforcing agency to properly carry out its responsibilities shall be appointed on an annual basis by the Mayor and Council of the Borough upon recommendation of the Fire Official. The Mayor and Council shall designate the salaries to be paid to inspectors or other employees.

§ 17-9.9 Qualifications for Fire Official and Fire Inspectors.

The fire official shall have the following qualifications:

In accordance with your request, this letter shall serve as our proposal for providing the construction inspection and management services for the above referenced project.

The following is an outline of the scope of the work, scope of our professional services and the estimated fee for our construction inspection and management services.

SCOPE OF WORK

The scope of the project consists of sanitary sewer repairs in areas identified in Phase 0 and Phase 1 of the Sanitary Sewer Repair Project, as specified in the project plans prepared by Gilmore Associates. The scope also includes reviewing the Boswell smoke testing report and the associated project plans, identifying any gaps in the repair areas specified in the report, and developing a strategy to address those gaps.

SCOPE OF PROFESSIONAL SERVICES

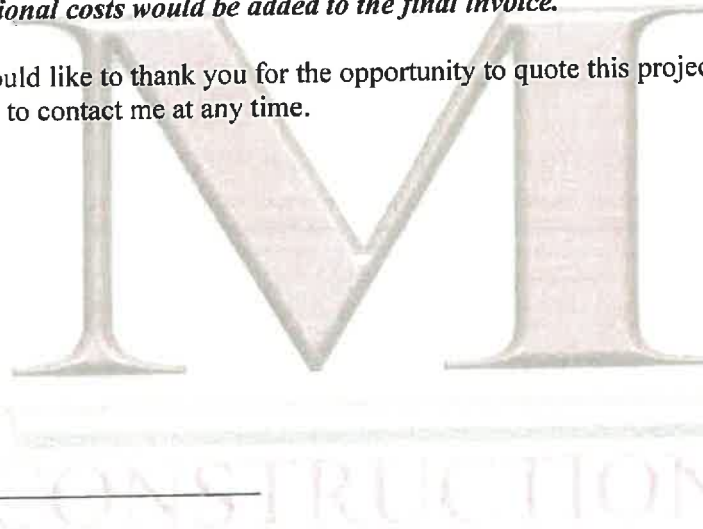

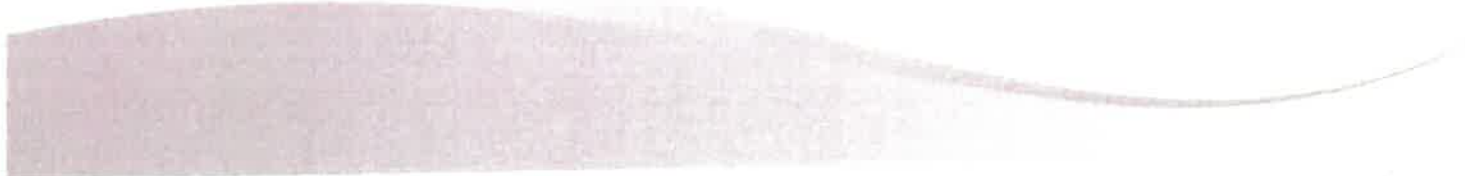

He will be supported by Gail Lalla, who brings expertise in energy and sustainability, and hands-on experience preparing Community Energy Plans.

Together, Dan and Gail have prepared Community Energy Plans for the following communities:

- Borough of Prospect Park (Passaic County)
- City of Union City (Hudson County)
- City of Garfield (Bergen County)
- City of Plainfield (Union County)
- City of Perth Amboy (Middlesex County)

Dan and Gail are also currently preparing Community Energy Plans for two additional communities awarded grants during the prior grant year.

SCOPE OF SERVICES

T&M will prepare a Community Energy Plan consisting of up to twelve (12) energy initiatives for adoption by Englewood Cliffs' Borough Council. The initiatives will be selected from a list of more than 40 options developed by Sustainable Jersey, in collaboration with a working group of Borough representatives. These efforts will help Englewood Cliffs leverage state resources to promote long-term sustainability, strengthen local energy systems and deliver economic benefits to the community.

In addition to preparing the Community Energy Plan, T&M's scope of work includes a stakeholder engagement presentation at one (1) regularly scheduled governing body meeting, unless an alternative meeting forum is provided by the client. This meeting will introduce the purpose and value of the Community Energy Plan to residents, local energy

- Within eight (8) months of the grant award date, the municipality must conduct a minimum of one additional public meeting to engage the community in the creation of the Community Energy Plan; and
- Within twelve (12) months of the grant award date, the municipality must finalize the Community Energy Plan through formal adoption by the municipal governing body via municipal resolution and submit a copy of the completed Plan to the BPU.

MEETINGS

- One (1) kick-off meeting with Borough representatives and Sustainable Jersey to review energy data and proposed initiatives to be included in the CEP;
- One (1) stakeholder engagement presentation to take place at a Governing Body meeting or alternative forum;
- One (1) presentation of the CEP to the Governing Body for adoption;
- Four (4) check-in and planning meetings with the client to review project progress and coordinate meetings and presentations.

DELIVERABLES

The following deliverables will be compiled by T&M staff with the assistance of the Borough:

- Complete the Community Energy Workplan Template;
- Complete a final Community Energy Plan utilizing the Community Energy Data and Workplan based on the Sustainable Jersey model "Gotham City;"

- Other tasks, deliverables, or projects not identified in this scope of work.
